SchoolPool partner schools are eligible to receive direct **monetary incentives** for participating in **two one-month long SchoolPool challenges** during the school year, one in fall 2019 and one in spring 2020. **School incentives are subject to available funding.**

Marketing and promotional materials, stock communications, event assistance and more are available to support your SchoolPool efforts.

I agree that my school will make a good-faith effort to:

- _____ **Conduct outreach to promote** the program and the use of transportation modes for trips to/from school such as walking, biking, busing, and carpooling to students, parents and staff.
- _____ **Display the promotional materials** provided by the SchoolPool team.
- _____ **Distribute the paper SchoolPool trip log calendars** to each student.
- _____ **Collect the trip-log calendars** from the students at the end of each challenge for pick up by the Bellevue SchoolPool staff.
- _____ **Distribute the student and staff incentives** provided by the SchoolPool program.

I further understand that:

- _____ The **maximum** amount of **school incentives** is **\$2,000 per challenge**, from which up to \$500 are Outreach incentives and up to \$1,500 are Calendar incentives.
- _____ The **maximum** amount of **\$500 Outreach incentives** per challenge is for four (4) communication attempts during the challenge. This amount is **contingent on providing proof of communication** (e.g. by cc'ing or forwarding communications to the Bellevue SchoolPool team email, providing screenshots or links to SchoolPool posts, etc.)
- _____ The **maximum** amount of **\$1,500 Calendar incentives** per challenge is for **75% student participation** and it is proportional of the rate of eligible trip log calendars returned.
- _____ The trip log calendars are **only eligible for school incentives, if (1)** students indicate they walked, biked, rode the bus, or carpoled at least once during the respective challenge, **(2)** student grade, student, school and teacher names are present, and **(3)** the calendars are **filled out by the students** and not by teachers or other school staff.
- _____ School incentives are **subject to available funding.**
- _____ School incentives are to be used for the **benefit of students** at my school.
