- \_\_\_\_\_ **Conduct SchoolPool activities** at the school.
- \_\_\_\_\_ **Report the SchoolPool activities** to the SchoolPool team at the end of each challenge.

- \_\_\_\_\_ The **maximum** amount of **school incentives** is **\$2,000 per challenge**, from which up to \$500 are Outreach incentives and up to \$1,500 are School Activity incentives.
- \_\_\_\_\_ The **maximum** amount of **\$500 Outreach incentives** per challenge is for four (4) communication attempts during the challenge. This amount is **contingent on providing proof of communication** (e.g. by cc'ing or forwarding communications to the Bellevue SchoolPool Team email, providing screenshots or links to SchoolPool posts, etc.)
- \_\_\_\_\_ The **maximum** amount of **\$1,500 School Activity incentives** is for three (3) activities conducted during the challenge, or \$500 per activity.
- \_\_\_\_\_ School incentives are **subject to available funding.**
- \_\_\_\_\_ School incentives are to be used for the **benefit of students** at my school.
